## General Manager Report

Positive Vibes Only is how we chose to approach the 2024 season and positivity is what we put out and received back beyond our expectations. The HCNC netball community has had a very successful season in so many areas both within our Centre and beyond. We have had national title winning teams, internationally selected umpires, Netball NZ Volunteer of the Year recipients, coaches selected to franchise and NZ representative teams and players and umpires who have represented the Centre at a wide variety of tournaments and events. Within the centre we continue to grow and develop all parts of our netball community within a fun, safe and welcoming environment. All of this is so important to us as we continue to work towards "Providing a lifelong community connection to sport through netball".

The Board in January changed my job title so that I started the 2024 year as General Manager. A move from Centre Manager to General Manager was felt to better reflect the responsibilities which have developed in recent years within the management role. It is also a recognition of the involvement and influence at both the zone and national level that I have been able to have on behalf of the Centre. At the end of the 2023 season the Board released the Poipoia te Manawa Strategic Plan. The move to a General Manager role supported this as it positions HCNC with the other large netball centres and other sporting codes management. I am proud of the achievements of HCNC in the last 7 seasons. We have been able to emerge as leaders in our sport and within the wider sporting community, through our commitment to giving our community the very best experience we can deliver on and off the court. Taking on the new title was exciting as was the new challenges that came with it.

The Positive Vibes Only campaign which we developed and piloted with Sport Waikato in 2023 is about setting the atmosphere and environment we want anyone involved in netball to feel and experience. It focuses on educating all our community on the behaviours we want to see on court, on the sidelines and anywhere our community interacts with netball. It starts with us leading by example. The first week of all competitions in the 2024 season, the first week back after the school holidays and the finals days, were when we asked everyone to dress up and show their support for the campaign. When you walk in the centre gates and you see a sea of pink and are greeted by our volunteers all dressed up with a big smile on their faces, you straight away feel the positivity and want to be part of it. Every competition got involved in this campaign with teams, supporters, umpires and bench officials dressing up and getting into the spirit. ## futureFERNS

This season, I was feeling more confident running the futureFERNS programme as last season I was brand new to the role. For the 2024 season, I was able to take full control of things and make changes that I thought would improve the programme. This season, we didn't have as many interruptions as in previous years. We had the usual wave of Winter flu; however, this didn't impact teams too much as player numbers in teams were unusually high this season. This meant that there were enough players in the team to still field a team. As usual, we also had teams willing to play extra games to help those who would otherwise miss out. The camaraderie in futureFERNS is awesome. Coaches talk to one another and are willing to help where needed.

### **futureFERNS Numbers**

Unfortunately, we had a decline in team numbers for the futureFERNS programme. Year 5-6 and Year 1-2 grades decreased by around 10 teams each. I believe that the team reduction for Year 1-2 & Year 5-6 could be due to the lack of people able to help with coaching. There were numerous schools contacting me regarding finding coaches and asking for help. Schools were entering less teams and instead increasing their player numbers in each team. This meant some teams had more substitutes on the bench than players on the court, which is a real challenge for the coach and players. Hopefully this will turn around for next season. Our Year 3-4's increased by 10 teams. This meant we almost had two full rounds on a Tuesday night.

## Skill of the Week & Rule of the Week

For the futureFERNS programme, the first 9 weeks consists of a "Skill of the Week". Previously, coaches/managers have struggled to find this content as they might not be registered online correctly. This season, I created a one-page PDF for each Skill of the Week that people could find easily on our website, print off, or forward to their team parents. I believe this worked quite well as people were able to look ahead to see what other skills their team would need to work on. This resource is available in much more detail on the Netball New Zealand website, however, not everyone knows to look there so I wanted to bridge the gap between the two. Alongside the "Skill of the Week" I also share a "Rule of the Week" for our Year 5-6 teams. The purpose of this is to upskill the players and coaches/managers, to create a safe space for upcoming umpires to develop their skills. Like the "Skill of the Week", I also created a one-page PDF that could be shared around. I believe that these were helpful for those who knew about them.

## **No Limits**

This season, we introduced our No Limits Programme which has been included in more details within this Report. Due to this, we included within our futureFERNS policy that there are "NO restrictions for ANY children that may have access, disability, or neurodiverse needs. ALL children can participate in futureFERNS netball." I believe that this was well taken by schools/clubs as we had multiple children with disabilities playing futureFERNS which is awesome to see!

## **Double up Leagues**

For the Summer League in February-March 2024 we decided to try to Introduction to 7v7 Grade to help those players who have just finished Year 6 and will now be going to Intermediate. The purpose of this was to give these players an opportunity to gain experience with the new netball format in a non-competitive environment before they are exposed to trials and games at school/club. Unfortunately, there were not enough teams interested, to go through with this Grade. We are hoping to get more interest in the Spring League which will be held in October-November 2024.

### **Festival Day**

The Festival Day for 2024 was a huge success! We had a significant drop in numbers; however, the same problem was noticed during the season. Not enough coaches to cover the number of teams. There were teams with double the number of players that were needed e.g., a 6v6 team with 13 players. Another factor that impacted some of our teams on the day was the passing of Kiingi Tuheitia Pootatau Te Wherowhero VII. Several teams were involved with the Tangi and were unable to come to the festival. Overall, the weather was amazing, fantastic costumes, and an incredible atmosphere.

## Player Development

2024 was another year of growth in player development at HCNC, especially through our Poipoia te Manawa programmes.

### Poipoia te Manawa Programmes

- futureFERNS (Year 3-6) Skill Sessions and Skill Camps
- Intermediate (Year 7-8) Development Sessions and Development Camps
- Under 14 & Under 16 Development Sessions and Development Camps

Skill and Development programmes are run in 6–8-week blocks during the pre-season, in-season, and post-season. We held Skill and Development Camps during the school holidays (April, July, September/October). In 2024, 297 participants joined Skill Camps, and 157 joined Skill sessions and Development programmes.

We continued the successful "Intro to 7v7" programme, which had 19 players and included a good mix of theory and practical aspects about netball and the rules. Included were warm-up techniques and "how to do a good warm-up", run by our NetballSMART Activator, Amanda Foster.

This year, we focused on evaluating and improving our programmes that enhance player and participant experiences, along with making them more visible and promoted better within the community.

## **Representative Programme**

We had over 120 trialists in the Under 14 & Under 16 age groups (Increase from 2023), leading to the formation of:

- 2 x Under 14 teams
- 2 x Under 16 teams
- 1 x Under 14 Development Squad
- 1 x Under 16 Development Squad

For Under 18 and Open age groups, we had 36 trialists (decline from 2023). The location of U18s in Dunedin created increased costs and we believe this was a contributing factor to a decrease in trialists. We were able to form:

- 1 x Under 18 team
- 1 x Open team

In 2024, the Under 17 Men's age group was changed to Under 18 Men, and HCNC had 1 x Under 18 Men's team.

### **Team Successes**

Our Under 14 and Under 16 teams attended tournaments in Auckland and WBOP, leading up to the North Island Junior Champs in Taranaki. Congratulations to our Under 16A and Under 16B teams for winning their respective grades.

The Under 18 team attended several one-day tournaments and placed 8th at the Netball NZ Under 18 Champs in Dunedin. The Open team after a hard-fought tournament, won the Netball NZ Open Champs at Auckland's Pulman Arena.

Attending Champs for our teams is a massive financial and time commitment so we thank our players for putting in the work and their whānau for supporting each player. Thanks to the Lion Foundation for their grant, which helped with travel and accommodation costs for the teams. This helps to lower costs, especially for our teams flying around the country.

Our Under 18 Men's team, Under 14, and Under 16 Development Squads had successful seasons, attending day tournaments and gaining valuable experience.

Our Development programme has grown over the past few years, and it is great we are able to offer more development opportunities for players to represent HCNC.

### **Centre Day**

We held a Centre Day for our Under 14, Under 16, and Under 18 teams to connect and prepare for the season. Claire O'Brien and Saviour Tui from the WBOP Magic attended, and we had Amanda from NetballSMART and Helen Eagleton for team photos.

### **New Uniforms**

We were fortunate to purchase new dresses for all our Representative Teams, which incorporate our Poipoia te Manawa logo. Our Hamilton City teams look amazing out on court. Thank you to NZ Racing Board funding who made it possible.

## **Representative Tournaments**

We hosted three successful tournaments:

- Age Group Representative Tournament (June): 62 teams participated.
- Open Representative Tournament (August): 5 teams attended, providing game time before Netball NZ
   Open Champs.
- **PDP Festival:** 9 Teams from the HCNC Year 7-8 In-Season Programme and teams from around the WBOP Zone attended. The whole day was a great celebration of competition, fun, and a bit of dress up from our PDP teams.

## **WBOP Magic in the Making**

We hosted a Magic in the Making cluster session with 38 players participating in fitness testing, coaching by WBOP Magic staff, and game play. Players had the chance to be selected for the Advanced session and the NZ NDC (National Development Camp) in January 2025.

## Wrapping up 2024

A huge thank you to all the volunteers, coaches, and managers who contributed to the success of our programmes, representative trials, tournaments, and champs. Special thanks to Val Temm, Sue Farrell, Susan Fell and Ihapera Kaihe, with all our representative trials. Andrea Hall, for organising our umpires. ## Coach Development

Each year, we aimed to improve coach development at Hamilton City Netball Centre. 2024 has been a great year with new initiatives and building on what we currently offered.

### **Coach Workshops**

Workshops were held throughout the year, mainly before the season started. This year, we had the following:

- futureFERNS (Year 1-6): 6 workshops, 79 coaches attended
- Intermediate Coaches: 1 workshop, 10 coaches attended
- Community Coach (CCA) Modules: (Target audience: Secondary and Club coaches)
  - o 9 x CCA1 modules
  - o 7 x CCA2 modules with coach observations
  - 19 coaches attended different modules across CCA1 & CCA2
  - o 5 coaches completed CCA1, 3 completed CCA2

### Poipoia te Manawa

We engaged more coaches into the Poipoia te Manawa programme this season to build their confidence across age groups. This helps improve player experience and development through coaching. Representative coaches also joined as guest coaches when possible.

## **Representative and Development Coaches**

Coaches for the Representative and Development programmes are selected through an interview process. They lead our teams with a focus on player development both on and off court, with support in season and beyond.

### **Community Coach Group**

A small group of community coaches have explored ways to support coaches at the Hamilton City Netball Centre. This year, they launched a few initiatives:

- A Coach Community Facebook page for coaches to share resources and support each other
- A Coach Corner on Saturdays for coaches to drop by for advice or a chat

Looking ahead to 2025, we're excited to see these initiatives grow and evolve.

## **Community Programmes**

### **Walking Netball**

Walking netball was introduced in Term 1 2024. It's a low-impact, alternative, for those rehabbing from injury, wanting to stay active, meet new people and have fun. It caters to all ages and genders. We started running 6-week block programmes then increased to 8 weeks, at the request of our participants. There were a lot of laughs, fun had and good-natured banter as to whether that was fast walking or running! The game has flexible rules and can be adapted for the number of people who turn up. Our youngest player was 6 and our oldest in her 80s.

### No Limits 2024

In 2024 Hamilton City Netball Centre decided to be part of the Netball New Zealand No Limits initiative. We believe that there should be no barriers to playing sport. Tamariki and Rangatahi should have opportunities to play sport and be included with their peers.

The biggest initial hurdle we had to overcome with this project was to find our "why". We thought we could do what the other centres are doing. We quickly realised that this didn't align with the centres Strategic Plan. One of our key pillars is "Manaakitanga – Embrace diversity within fun, safe, and welcoming environments". We want to make "netball the ultimate experience for everyone". It came down to that we want kids to see their potential and see that they are capable of so much more than they are given credit for due to their disability. We want to embrace diversity so that everyone can have fun together in the environment we have created.

We established early on that there is a big difference between integration and inclusion. We saw kids being integrated into netball and sport by having restrictions put on them, therefore singling them out. For example, playing netball but that one player gets a hoop that's half the height. We wanted to change that by fully including them into our netball community. We are aiming to upskill the disabled kids so that they can be included into their school/club teams. However, we understand that this is dependent on the disability and adaptions may be required. If someone has a visual impairment, we have different coloured balls and bell balls that will help them play, without singling them out and altering the game.

As a first step, we decided to focus on futureFERNS and work our way up. We want to provide kids with disabilities, the opportunity to develop their skills so they might feel confident enough to join their school teams. Thus, including them, rather than just integrating them.

2024 was spent upskilling our staff members with inclusion trainings to better understand our intended community. Our next step was to go out and see what people are already doing in the community. We went to different netball centres to see how they were operating; and we went to the Halberg games to brainstorm with other coaches in the community to see first-hand how incredible the kids in this community truly are. Through these experiences we built connections with people from different organisations, such as Halberg, Special Olympics, Parafed Waikato.

We have learnt that the No Limits space is going to be continuously evolving. Each child we meet is different. We need to continue developing our coaching abilities to provide these kids with amazing opportunities.

## **Umpires**

The start of 2024 saw our Umpire Leadership team lead the education rollout and implementation of the new World Netball Rules 2024. This was a mammoth task and one that as a centre we did above and beyond other centres to ensure our umpires, players and the wider community understood the changes. 23 online and face to face rule update sessions were delivered at the Centre and out at schools. These were attended by 210 people. There was also a social media and website campaign which highlighted the rules and gave links to World Netball videos and resources to further explain the rules. The rollout into our competitions went really smoothly which we firmly believe was due to the time and effort spent on education.

263 umpires were registered at HCNC in 2024 on the umpire award pathway. This is an increase of 24 umpires from the 2023 season. It is thanks to our 18 hard working Umpire Coaches that each of these umpires was able to receive coaching and work towards completion of their next award.

The Umpire Leadership Team of Andrea Hall, Caitlyn Forrest, Fiona Miller, Ruth Robinson, Sophie Macintyre and Taina Fink continue to develop robust processes and systems to support what is a large and complex community of umpires. Each member of the team takes on an area of the community from course facilitation development to Umpire Coach development to Duty Umpires to Representative pathways and everything in-between and coordinates an army of volunteers to ensure all our umpires are supported here at the Centre and wherever they go within the umpire pathway. It was fantastic to have two of our Leadership Team recognised at the Netball New Zealand Volunteer of the Year Awards. Caitlyn Forrest won the Youth of the Year Award for her outstanding contributions in the umpire space. Sophie Macintyre was Highly Commended in the Official of the Year Award for her huge amount of input into the umpire community.

I believe it is through the support network that we are continuing to develop, that we are seeing so many successes in awards received including in 2024 McKenzie Northcott receiving her NZ B Award and Caitlyn Forrest, Jesscia Clark, Nicole Jackson and Marilyn Hodder receive their NZ C Award. This is a huge number of NZ Awards for the size of our Centre.

We are so proud to turn on our TVs and see Tania Fink umpiring in ANZ games and internationally. Tania inspires our young umpires and shows them that you can go from HCNC to the world stage with your umpiring. And even better Tania comes back to grassroots netball at our Centre and helps us bring through the next generation.

## Basis of Preparation

This performance report is prepared in accordance with the XRB's Tier 3 (NFP) Standard. The entity is eligible to apply these requirements as it does not have public accountability and has total annual expenses of less than \$5,000,000. All transactions in the performance report are reported using the accrual basis of accounting. Hamilton City Netball Centre Incorporated is wholly exempt from New Zealand income tax having fully complied with all statutory conditions for these exemptions.

### Bank Accounts and Cash

Bank accounts and cash in the Statement of Cash Flows comprise cash balances and bank balances (including short term deposits) with original maturities of 90 days or less.

### Revenue

Revenue is recognised to the extent that it is probable that the economic benefit will flow to this entity and revenue can be reliably measured. Revenue is measured at the fair value of the consideration received. The following specific recognition criteria must be met before revenue is recognised.

## Revenue from providing goods and services

This entity receives revenue from providing goods and services mainly from registrations, tournaments, and programmes. This revenue is from both members and non-members, and whilst the majority is from members, it was impracticable to distinguish which portion was non-member related.

## Grants, sponsorships, and other contract income

Grants, sponsorships, and other contract income is recognised when the documented expectations over use of funds are satisfied.

### Interest income

Interest is recognised as it accrues, using the effective interest method.



## Deferred Revenue

The deferred revenue at balance date reflects the extent to which the documented expectations over use of funds received have not yet been satisfied.

## Property, Plant & Equipment

Items of property, plant and equipment are measured at cost less accumulated depreciation and impairment losses. Cost includes expenditure that is directly attributable to the acquisition of the asset. Depreciation is charged on a basis of Straight Line or Diminishing Party as appropriate. Depreciation is charged at rates calculated to allocate the cost of the asset less any estimated residual value over its remaining useful life.

## Investments (Term Deposits)

Investments include term deposits are record at cost.

## Changes in Accounting Policies

There have been no changes in accounting policies. Policies have been applied on a consistent basis with those of the previous reporting period.
